WCIT-12: Comments and Discussion

- December 2012, Organized by ITU
 - Review the International Telecommunication Regulations (ITRs)
 - International treaty
 - Established in 1988
 - Focus on operator compensation for international voice calls
 - Amendments will lead to new treaty
 - Conference participation strictly regulated
 - One vote per accredited country delegation

WCIT-12: Comments and Discussion

- “Two camps”
 - Camp 1: “Bring Internet under ITU jurisdiction”
 - “Apply fixed phone line principles”
 - Proposals include “sender pays”, “charge over-the-top (OTT) providers”, introduce Quality-of Service (QoS) in addition to “best effort”
 - Allow for better control (aka “license for censorship”)
 - Considered as camp 1 members: China, Russia, ETNO (“Who is who” of incumbent telecom operators), and others

WCIT-12: Comments and Discussion

- Camp 2: “If it ain’t broke don’t fix it”
 - Don’t touch, multi-stake holder principle has been working very well
 - Two billion users, and it is done on a handshake
 - Internet brought prices for data down to a 100,000 times less than that of a voice minute
 - SMS and iMessages: 28,000 iMessages / s
 - QoS: “V. Cerf: QoS is like putting a gun at your head”
 - Camp 2 proponents: Internet Society (ISOC), Euro-IX, EuroISPA, USA, European countries, EC, and others

- Current status
 - ITU has asked for public opinions and views (until 3 November)
 - Amendments have been proposed (see ITU Web site)
 - Conference preparations taking place in the member countries
 - ETNO proposal rejected in several countries
